T3 - Silver Birch - Reshape and reduce crown by 3 to 4 metres, give balance and shape, prune back lateral branches interfering with gable end of building, dead wood crown and thin where appropriate.
T4 - Reduce and reshape crown by 2 to 3 metres to give balance and shape. Dead wood, Thin and Lift crown where appropriate.
T5 - Reduce and reshape crown by 3 to 4 metres Thin and Lift crown where appropriate.
T6 - Reduce and reshape crown by 3 to 4 metres Thin and Lift crown where appropriate.
T7 - Reduce and reshape crown by 3 to 4 metres Thin and Lift crown where appropriate.
T8 - Reduce and reshape crown by 2 to 3 metres to give balance and shape. Dead wood, Thin and Lift crown where appropriate.
