e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Proposed works: T1 Cedar Fell and replace with a suitable specimen

Reasons: The canopy frameworks structure is dense with many secondary crossing & rubbing branches, creating wounds and historic failures of the canopy structure. Historic and recent branch failures are creating and increase risk of failure over the public highway which is frequented often (high target).

Repeat regular damage to the front boundary wall, which has required repeated remedial works to rectify at a cost. The upward movement from the tree roots are creating a potential hazard to the users of the highway.

Repeat damage to the driveway, with roots uplifting the surface, which has required repeated remedial works to rectify at a cost.

Due to the tree type, crown reduction, thinning or crown cleaning is not considered appropriate options leaving a tree of undesirable form and altered exposure of the remaining canopy. Therefore, no suitable remedial works can be considered to reduce risk of further branch failure, without creating a tree of reduced amenity value with undesirable form and structure. The proposal to fell and replant appears to be the most viable option in terms of maintaining visual amenity.
