e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

T1 - Acer psuduplatanus - Remove all deadwood from crown and reduce by 3-4m leaving a height of 15m and a radial spread of 7m. This is once the deadwood is removed it will leave the tree slightly misshapen. The idea is to bring in the longer extended branches to leave a more uniform shape and avoid heavier branches snapping out.
