e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Works to trees at The Nook Cosby:

- to raise crown of alders T14 and T15 to 5 metres over the road;
- to repollard willow T1 by pelican crossing/bridge;
- to remove major dead wood from hawthorn T26;
- to raise crown of plane T2 to 5 metres over the road;
- to prune cedar T3 lightly to give clearance around sign;

Works to trees on Main Street, Cosby:

- to raise crown of willow T4 opposite Bangla Spice to 5 metres over the road;
- to raise pollarded willow T5 over layby to 5 metres;
- to remove dead wood from hawthorn T6 near bridge, to prune away from the bridge and to reshape;
- to raise hornbeam T7 opposite Old Vicarage to 5 metres over the road;
- to raise acacia T41 to 5 metres over the road;
- to raise horse chestnut T8 to 5 metres over the road;
- to raise hornbeam T9 to 5 metres over the road;
- to raise birch T10 over road and bridge to 5 metres.
