e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Horse Chestnut (T1) - Branch – East side at 4.5m, reduce by 2.5m (PIC1). Branch – South side at 5.5m, shorten upright branches on end by 2.5m (PIC2 & PIC3). Branch – West side at 3.5m, reduce by 4m (PIC4)

Reason - Ongoing general tree management to prevent branch fractures due to heavily end weighted stems in snow or strong winds.

Horse Chestnut (T2) - Reduce side branch at 16m above ground level on south east side by 4m (PIC5)

Reason - Ongoing general tree management to prevent branch fractures due to heavily end weighted stems in snow or strong winds.
