Tree 1 – Oak tree

The Oak tree is a tall quite spindly example with the growth predominantly on one side, this is due to being previously suppressed by an adjacent tree that failed in storms some 10+ years ago

In order to preserve the tree and ensure it remains safe to reduce the height by approximately 30/35% and prune to balance the crown
