Sweet Chestnut 37 - Raise low canopy over road to 5.0 metres & footpath to 2.5m; removal epicormic growths;  
Hornbeam 38 - raise low canopy to 4.0 metres site side only;  
Reasons; Good arb management - all recommended following recent tree survey.
