OUTLINE PLANNING APPLICATION FOR DEMOLITION OF THE EXISTING BUILDINGS AND THE ERECTION OF A NEW RESIDENTIAL SCHEME (C3 USE TO INCLUDE AFFORDABLE HOUSING) AND ASSOCIATED LANDSCAPING, ACCESS AND SUPPORTING INFRASTRUCTURE, LAND NORTH OF LONG COPSE LANE, EMSWORTH, PO10 7UL.

Further to significant pre-application consultation with the Council over the course of the past five years, we are delighted to submit an outline planning application to consider the principle of development for the larger portion of the Policy H8 draft allocation located at land north of Long Copse Lane, Emsworth.
