<u>Town and Country Planning Act 1990, Section 211 - Notification of Intention to carry</u> out work to trees within a Conservation Area at 14 Lower Camden Chislehurst BR7 <u>5HX</u>

Thank you for your application received on 10th September 2021 in which you notified this Council of your intention to carry out the following works:

- Black Poplar tree in rear garden (Tree A) Remove.
- Black Poplar (Tree B) Reduce branch by 4m.

at the above address which is situated in the Chislehurst Conservation Area.
