Town and Country Planning Act 1990, Section 211 - Notification of Intention to carry out work to trees within a Conservation Area at 14 Lower Camden Chislehurst BR7 5HX

Thank you for your application received on 10th September 2021 in which you notified this Council of your intention to carry out the following works:

- **Black Poplar tree in rear garden (Tree A) - Remove.**
- **Black Poplar (Tree B) - Reduce branch by 4m.**

at the above address which is situated in the Chislehurst Conservation Area.

This Council now has six weeks to consider the intended works and determine whether it would be appropriate to make a Tree Preservation Order for the trees which are to be subject to the proposed works.
