Since 1961 Aldenham House, including the surrounding gardens and parkland, has been used as a school. The 4x historic sets of steps will form part of a future route between the Boys' and Girls' schools. These were previously separate institutions, but will work together more closely going forward, including sharing buildings and facilities. The path will therefore be in constant use, which was not the case previously. The proposals to repair the existing steps are therefore entirely valid and lawful given that they currently present a health and safety risk to staff, pupils and visitors in their current state. Crucially, the repairs will be undertaken in a like-for-like, traditional manner that will match the existing exactly.
