

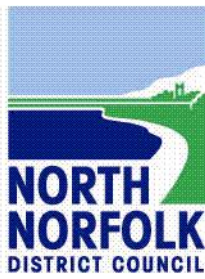

e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Sycamore (T1) - Prune around BT line and lift roadside limbs to 2.8 metres, reducing to suitable growth points where necessary  
Beech (T2) - Prune around BT line and lift roadside limbs to 2.8 metres, reducing to suitable growth points where necessary  
apple (T3) - reduce by 2 metres to suitable growth points  
plum (T4) - remove - suppressing surrounding trees and adds little amenity value  
Plum (T5) - reduce by 1 metre  
apple (T6) - reduce by 2 metres to suitable growth points  
Scots pine (T7) - raise canopy by 2 metres  
apple (T8) - remove, low amenity value  
apple (T9) - reduce by 2 metres to suitable growth points  
apple (T10) - reduce by 2 metres to suitable growth points  
contorted willow (T11) - lift lower limbs  
willow (T12) - lift lower limbs  
Norway maple (T13) - reduce by 2 metres to suitable growth points  
variegated maple (T14) - reduce by 2 metres to suitable growth points  
Norway maple (T15) - reduce by 2 metres to suitable growth points
