Proposals for new limestone terraces have already been publicised and consulted on as part of an existing planning and listed building consent (consent has already been granted). During detailed design, the terraces have been re-designed in order to reduce their scale, massing, footprint and complexity. This was in response to the historic building, so as to further minimise heritage impact, and as part of a carefully considered landscape plan for the north forecourt.
