On behalf of our client Harris Strategic Land, I am writing to formally submit an Outline Application for: 20 dwellings, including bungalows and affordable housing; open space; landscaping; and associated infrastructure, on land south of Forest Road, Onehouse.

This Outline Application seeks to secure: Access; Layout; and Scale for the site on land south of Forest Road, Onehouse, and is made in accordance with both current and emerging local policy and adopted documents.

The site is an identified allocation within the emerging Babergh Mid Suffolk Joint Local Plan (LS01 067) and is included within the proposed extension to the eastern boundary of the village of Onehouse.
