T1 Tree tag 001553. 18 meter high Acer platanoides. Cavity identified approximately 3 meters up main trunk. extent of cavity is unknown. We suggest a reduction of 30% to reduce weight of canopy thereby reducing strain on holding wood.

T2 Tree tag 001551. 18 meter Horse chestnut- cavities identified in first crotch. We suggest a 30-40% reduction to reduce the weight of canopy therefor reducing strain on holding wood.
