e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Field Maple (FM) - This is a splendid old tree. Large, multi-stemmed specimen at front of property. Recently placed under TPO protection to prevent felling. Tree has historically been "pollarded", resulting in a very bushy form.

Reduce height and spread by up to 2.5m. Retain good foliar crown and shape to a balanced form. Thin crown by 10% to decrease density of regenerative growth. As part of good management of old pollarded tree.
