We wish to extend to the rear of our property to create a new kitchen/dining room. The proposed rear extension will replace our current conservatory and will extend to 3.68 m beyond our original dwelling. The width of the extension will run the width of the current property apart from a narrow corridor (0.5 m) which will create a gap between our adjoining neighbour's extension and ours. The roof will be a pitched tiled roof along with 3 Velux windows. The extension will feature a side entrance doorway as well as a rear facing window and set of patio doors.
