We applied just under 2 years ago and sent a detailed drawing I can see is still on your website. Like our adjoining neighbours we have planted many trees and shrubs as shown and the all need regular trimming and reduction to keep safe and healthy and to stop over shading and to stop the trees becoming unmanageable especially as we are becoming older. The trees need to be kept healthy to allow them to continue to bear fruit and also not over shadow each other. The also over shadow our vegetable garden where we try to be self sufficient. The nature of the trees is to grow and this need to be rebalanced by reducing the crown correctly and stop them competing with each other.
