T5 Maple lateral reduction by up to 3m max pruning cuts 70mm to prune off the property
T6 goat willow lateral reduction by up to 4m max pruning cuts 70mm to prune from the lawn side, growing to far into the garden
T7 silver birch lateral reduction by up to 4.5m max pruning cuts 70mm to prune from the lawn side, growing to far into the garden
T8 conifer crown reduction by 5m to reduce the risk of failure, main trunks at the base have included unions and if left to grow a lot bigger, have a high risk of spitting out, due to too much weight on the weakness at the base.
All the above to be pruned to the marked lines on the attached photos
