- Alder (T15) - Crown lift to 2.5m over carpark and to clear boundary wall
- Maple (T16) - Crown lift to 2.5m over foorpath
- Alder (T17) - Crown lift to 2.5m over foorpath
- Silver Birch (T18) - Crown lift to 2.5m over foorpath and reduce crown by approx 1.5m
- Mixed Species (G1) Mainly Buddleja, cherry and Birch - Cut back to boundary and to clear wall by approx 1m
