S1 - x 1 Neighbouring Sycamore overhanging the rear corner boundary to have overhanging branches pruned as required to remove the majority of the overhang.

REASON: Maintain tree to its environment. Minimise nuisance and improve light to garden.

Plan A - Stonehall

HG1 - Neighbouring large Laurel and Holly hedge to be reduced in height. Final height to be at current trimmed up to level. Overhanging side only to also be trimmed back as hard as possible, whilst maintaining greenery. Height reduction to also include the thinner part of the laurel hedge which is next to the property.

A1 - Neighbouring Ash trees to have overhanging side only pruned back as much as possible, to remove the majority of the overhang.

H1 - x 1 Hazel and HC1 - x 1 Horse Chestnut to be felled.
