Reduction in height and pruning of 1 eucalyptus tree to prevent excessive shading, leaf fall and general encroachment into neighbour's garden (tree is over 15m tall)  
Reduction in height and pruning of ornamental cherry tree to reduce risk to conservatory from overhanging branches. This tree is in neighbour's garden but most of branches are in our garden. Discussed with neighbour who is content with proposed plan.
