Our current energy system is running on oil, our radiators have no individual valves and the boiler is an 20-year-old Esse stove which is highly inefficient. This affects our energy efficiency and carbon emission and running costs.

We would like to replace the oil system with a more sustainable and energy efficient air source heat pump. We have spent great care to find a way to install such a system without impacting the original appearance of our house by placing the fans further away from the property, hidden between shrubs and trees which will also reduce noise. We also believe that the more constant temperatures such a system holds will help us to fight dampness and therefore better preserve our building long-term.
