T2: Ash- Deadwood removal and removal from canopy and 2-3m side reduction on aspect of tree extending over lawn.  
T3: Ash-Deadwood removal and removal from canopy and 2-3m side reduction on aspect of tree extending over lawn. Removal of 2x lowest limbs extending towards Yew tree to promote growth of Yew tree and eliminate competition.
