The tree is becoming far too large for it's situation and it dominates our property taking away our enjoyment of the garden casting deep shadows over the majority of the garden from early

afternoon. We would like to raise the crown to a height of 5 metres and reduce the crown back from current radius of 12m to 9m (removal of approx 3m radius) We have contacted Happy Habitats who confirmed that all works will be carried out to BS3998. We believe that this work will not have any significant impact on the visual amenity of the tree.
