could to pruned again, as the upper branches are now touching the cable above. Steve Moses from AC Landscapes has looked at the tree. He is happy to carry out the pruning, but feels, like me, that the tree is showing signs of Ash dieback and it might be more prudent to fell the tree now, instead of pruning now and then having to fell it another day →

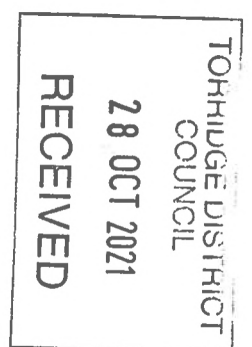
