5. Identification of Tree(s) and Description of Works e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position. (Please also refer to A = Main Plan and B = Key to Main Plan.) Trees 1a to g - Leylandii. Situated at the back of house in rear garden. Request to fell. Danger to house, shed and cars. Interfering with neighbours light. This is a group of 7 Leylandii trees which, from the road, look like one large tree. The tallest is approximately 16 metres high. Tree 2 - Cypress. Situated to the side of house in side/front garden. Request to fell. Danger to house and cars. Height is approximately 6.7 m. Tree 3 - Fir tree. Situated next to gate at entrance of house. Request to fell. It is growing into the beech hedge and gate. Would prefer to extend beech hedge. Trees 4 and 5. Prune. Situated in front garden next to (and in) the beech hedge by the road. Request to reduce crown. The branches need to be cut away from the service wiring along the street and brought within the boundaries of 2 Dairy Farm Cottages. Some branches are a few centimetres from neighbour's garage of Croft House. Approx height 6.5 and 7.5 metres. Tree 6 Beech and Tree 7 Yew. Request to reduce crown. Both trees (mainly beech) overhang boundary into neighbour's side yard. Danger to neighbour's high. house. The beech is 11.7 metres and the Yew approximately 7.4 metres high. 6.
