I am proposing to reduce the crown of the conifer (labelled T1 in the sketch) by around 30% as it is severely blocking light to my property and garden. Additionally, some of its branches are overhanging into my neighbour's garden (10 Bethel Road) when they park their car, posing a risk of falling in poor

weather conditions. The tree has been damaged too, presumably by large vehicles using the road, or backing out from the current building site on the other side of the road.  
I moved into the property last month and it had been vacant for many months prior, so the trees and garden have had little maintenance.
