The tree is a chestnut that has previously been heavily reduced and as always happens with chestnuts. At the point where the tree was reduced to has decayed and the re-generated growth has reached a stage where the weight and leverage are causing them to fail. The tree needs reducing back to the original reduced point and any significantly decayed limbs removed.
