The re-use of the buildings and the addition of 2 single car port is not likely to result in significant harm. The changes proposed are broadly sympathetic to the buildings and the replacement roof is considered appropriate and will preserve the simple functional character of the buildings. Fenestration should be recessed and the doors half glazed/half timber. No objection to basement if no significant adverse impact on structural stability of building. Courtyard should not be subdivided and landscape proposals should respect rural character.
