Some time before we moved to 43 Carlton Road the top part and side of the tree were removed and the remaining part is most unsightly. It is an eyesore and has a negative impact on the street scene. We propose to replace with one standard Himalayan Birch in same position. this will be compatible with the local treescapes where birches are frequently seen. 6.
