Silver Birch (T2) Fell and stump grind, large ornamental Silver Birch to be removed to increase light into garden  
Pear (T3) Reduce in height from 6m to approximately 3m, cutting back to live growth points in each instance. work to allow light into garden  
Maple (T4) Fell and stump grind. Works to allow increased light into garden.  
2 no. Lime Trees (T5&T6) - Reduce western radial spread from 3.5m to 1.5m.
