e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Magnolia (T1) -The tree is positioned in the middle of the garden. The tree is healthy and in a good condition however it is leaning heavily to one side. There is a potential risk of the tree splting in half as there is a very large fork down at the ground. The prosed works will be to reduce the tree by 1.5 metres back to previous pruning points. This will reduce the risk of the tree splitting and will improve the overall shape.

Damson (T2) - The tree is positioned in the rear garden. The tree has several visable fungi brackets on it, there is large amounts of deadwood within the canopy. This tree has not developed any good fruit or foliage this year. The prosed work is to completely remove tree down to ground and to replace with another fruit tree within the garden.
