**Proposal: Details of waste storage and Operational Management Plan pursuant to conditions 12 and 18 of planning permission dated 23 January 2018 (RN: 17/07355/FULL).**

Thank you for your recent response to our email dated 1 October 2021 requesting further information in respect of your application received on 11 June 2021. Regretfully I am writing to inform you that your application is still incomplete for the following reason(s):

- 1 The waste provision shown in the Operational Management Plan (OMP) shows no more detail than that submitted in the original application. Although a bin store was indicated on the image within the OMP, the waste detail submitted are not in line with the council waste storage requirements. Three to four different waste streams are expected from this development which are food waste, waste cooking oil, general waste, and recyclable materials. The three or four waste streams must be stored separately in different bins. You need to confirm the bin capacity for each waste stream.

The bins should be indicated and labelled O (for food waste), WCO (for waste cooking oil), R (for recycling) and W (for waste) on the drawing. Please refer applicant to the City Council Recycling and Waste Storage Requirements
