T5 Cedar by greenhouse Lightly prune back from green house by up to 1.5 m. Lift remaining canopy by up to 1m by the removal of secondary branches only
T6 Cypress by greenhouse Remove 1x low branch growing towards greenhouse
T9 Purple plum on rear lawn Prune back the lowest overhanging branch towards house by up to 2m.
