The tree is outgrowing it's current location. It is on the bank of the stream and therefore does not have strong roots in all directions, it is vulnerable to flood erosion. The tree is directly opposite the cottage, if the tree were to fall towards the cottage it would hit it and cause damage. The group of trees at the side of the access road have branches which overhang the road and prevent tall vehicles from accessing the property, they also overhang the Bank House garden wall.
