the new structure will be a detached structure set to the rear of the site, 1m from the boundary wall. It shall be a dual purpose garage for the school mini bus and additional gym space to cater for social distancing throughout the class schedule. the main vehicular entrance will be in line with the existing site vehicle entrance.  
The structure will be set on a reinforce concrete base with a floor dimension of 7m x 10m, and will be a steel framed mono pitch roof to the portal frame, 3m to the lower end rising to 4m to the front end, with a single skin cladding system, with 1x roller shutter door and 1x pedestrian entrance.
