Yes you would need to complete a listed building consent application. You can apply online via our website: <https://www.shropshire.gov.uk/planning/applications/submit-an-application/>. You would need to include a location plan, plans and drawings to show where the new flue will go, you need to also include a heritage impact assessment which assesses whether the installation would have any impact upon the fabric or character of the listed building and a Design and Access Statement which describes the proposal, including relevant photos etc, you can combine these into one document. The process is similar to the planning application process so the time frame is the same 8 weeks, although there is no fee for a listed building consent application.
