TOWN AND COUNTRY PLANNING ACT 1990

Proposal: Orangery extension at East Wing Clopton Hall Main Street Clopton Kettering Northamptonshire NN14 3DZ.

I refer to the above application received on **6 December 2021** but have to advise you that it is **INVALID/INCOMPLETE**. In order to enable further progress to be made, please supply the following:

1. Thank you for the drawings submitted with your application, although some dimensions have been provided. As per our published Local Requirements, "All plans and drawings must be drawn to an appropriate metric scale (1:50 or 1:100) and have all relevant dimensions of the key elements of the proposal clearly written. This includes the height, length, width and (if relevant) the distance from the site boundary of any proposed works.

We require this so that the proposed dimensions are clear when plans are viewed online." This is required as we now run a completely paperless planning office.

Please provide amended drawings including all relevant dimensions of the proposal:

• Dimensions for the site layout/block plan. The plan must be to a scale appropriate to the site and development (normally 1:500 or 1:200), showing distances from the site boundary of the proposed works (Drawing No. CO.EW.P04).

This will allow the officer to assess any potential visual impact of the scheme.

- 2. The submitted 'location plan', does not include the access within the red outline. Unfortunately, we are not able to accept this plan, as per National requirements, http://www.east-northamptonshire.gov.uk/downloads/file/9124/local_list_of_information_requirements a continuous red line should be around the entirety of the site, up to and including the access to the highway. Please provide an amended location plan accordingly.
- 3. All applications involving operational development on sites that contain trees, or where they are present on an adjacent site, will be required to be accompanied by the arboricultural reports/plans detailed below:
 - Tree Survey
 - Finalised tree retention/removal plan
 - Tree protection plan
 - Retained trees and root protection areas shown on proposed layout plan
 - Arboricultural Impact assessment

All documents must be in acutance with guidance set out in 'BS5837:2012: Trees in relation to design, demolition and construction' and the Council's Trees and Landscape SPD as per our published Local Requirements As per our published list of Local Requirements http://www.east-northamptonshire.gov.uk/downloads/file/9124/local_list_of_information_requirements
