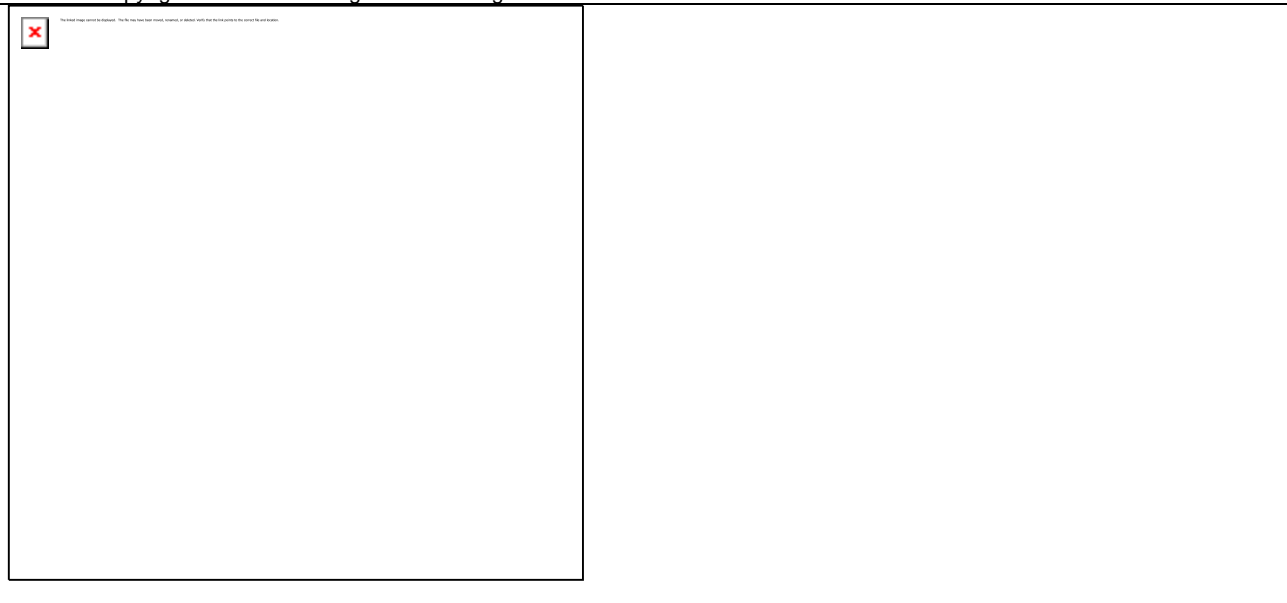
WHAT HAPPENS IF I MAKE REPRESENTATIONS?

Your representation will be acknowledged. Any representations you make will be open to public view (both at the Planning and Building Standards office and on the internet). Material representations will be taken into account by the Council when making the decision provided they have been received within the notification period. You will be advised in writing of the Council's decision. Anonymous objections will not be considered. You **do not** have the right of appeal against this decision.

Most applications are dealt with under the terms of the Scheme of Delegation. This is available online at <http://www.glasgow.gov.uk/planningguidance>. Other applications are presented to the Planning Applications Committee for decision. In some cases, this Committee can take the final decision on the application, whilst in other cases the application requires to be referred to the Full Council. Irrespective of how the application is decided, any material objections you submit within the specified period – normally 28 days – will be considered in the decision-making process.

Glasgow City Council is registered under the Data Protection Act 1998. The Council is under an obligation to properly manage public funds. Accordingly information that you submit may be used to prevent and detect fraud and may be shared for the same purpose with public bodies or other organisations which handle public funds.
