e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

T1 - Holm Oak - Height reduction of 3m to leave 14m height and 2m reduction of radial crown of north-western side to leave 5m radial crown spread. No cuts to be greater than 30mm diameter. Note - Although the result of the assessment found the tree to be within safe limits, following discussion with Mr and Mrs Adam and considering their concerns regarding the size of the tree and the species ability to tolerate pruning, I feel a crown reduction feasible. A sympathetic crown reduction and lifting would help reduce shading of the south facing aspect of the dwelling and help to alleviate the Adam's concerns. [REDACTED]
