e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

T1-T2- horse chestnuts- crown reduction by up to 2m back to previous pruning points.

T3- T4- conifer- crown reduction by up to 1.5m back to previous pruning points.

G1- this group is made up of conifers, sycamore, ash, holly and hawthorn. We wish to reduce it back down to previous pruning points. About 4.5m.

T5-ash- fell - poor health and rot at the base.

T6-T8 horse chestnut- re pollard back to previous pruning cuts.

T9-T10- hawthorn, crown reduce by up to 2m to previous pruning points.

T11- sycamore- crown reduce by up to 3.5m to previous pruning points.

T12- castlewellsen conifer- crown reduce by 1m back to previous pruning points.

T13- purple leaf plum by up to 2m to red line in attached photo.

All this pruning work was carried out in 2019. We wish to prune everything back to replicate these works.
