Tree E (Cherry), 22ft height x 18ft spread. Crown reduction to 16ft height x 12ft spread. Reason is that tree encroaches on property front entrance and border hedge.

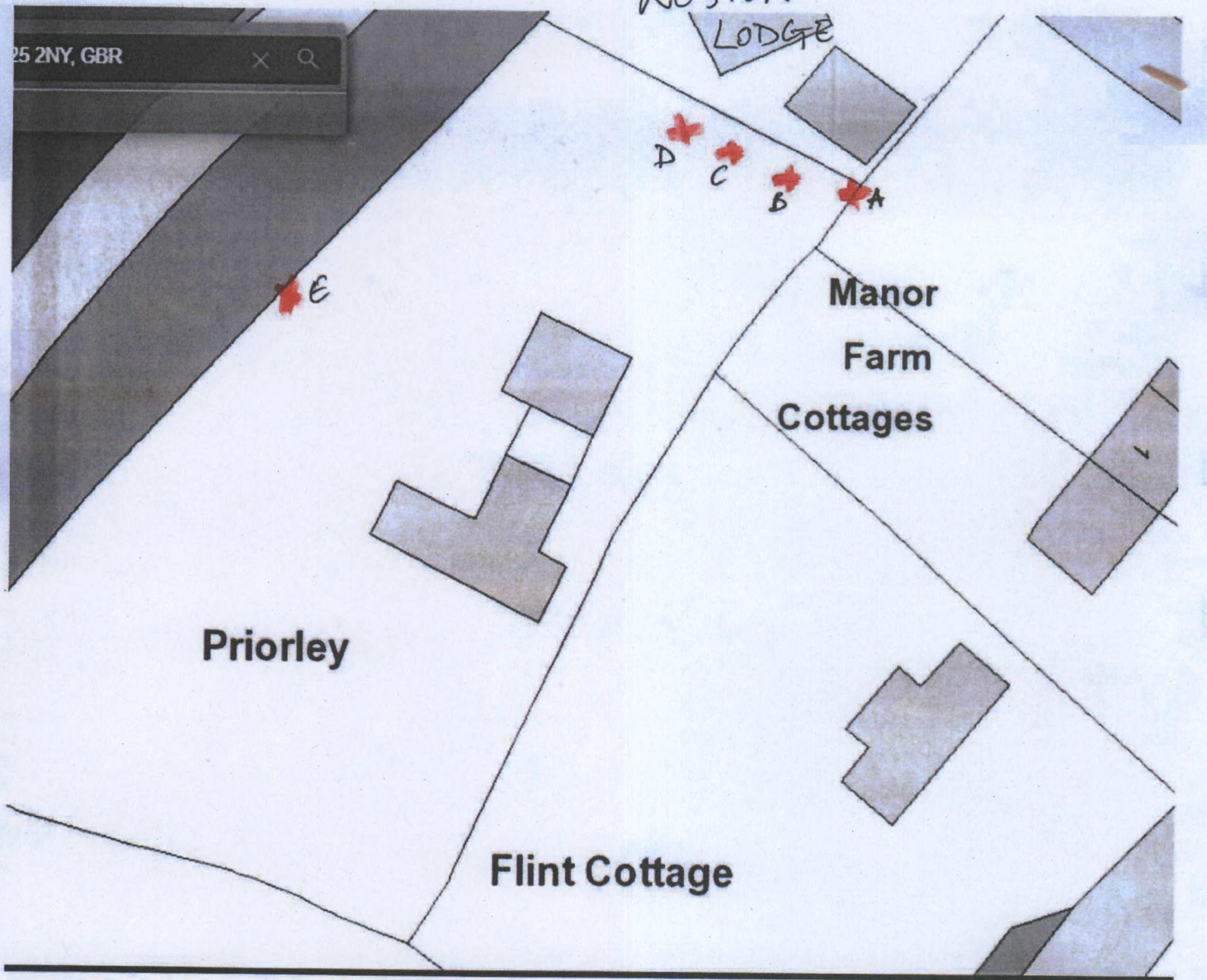
