Thank you for providing Lancashire Constabulary Designing Out Crime Officers (DOCO's) with the opportunity to comment on this amendment to the above application. The recommended security measures for the scheme made within the Crime Impact Statement (CIS) dated 06/11/2019 are still relevant to this application and should be implemented by the applicant.

As detailed in the Crime Impact Statement the scheme should be developed to the police preferred security specification Secured by Design. In order to ensure that products installed such as doors and windows are Security Rated (SR) to their relevant industry standard I recommend that the scheme is designed and constructed to Secured by Design 'Commercial 2015' security specifications. Security measures in new developments are required to prevent and fight crime and to keep our Communities and People Safe in accordance with -

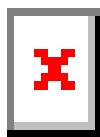
