e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Beech tree in the rear garden as marked 'Tree 1' in Sketch Plan 1 attached.

Permission to fell to near ground level due to it's location at the rear of the property does not suffice to provide substantial amenity value to the public and creates numerous issues for the homeowner. Concerns of failure from a large crack formation at the collar where the limb attaches to the main tree stem. Water, dirt and other unwanted material falling into the crack and causing continuing rot and decay is an ongoing concern for the safety of the limb, its size and proximity to houses. The reason for removal is also due to heavy shading of multiple gardens throughout the day but most affecting the garden and property of 7 Ferndale Drive, resulting in the need for lights on inside the house during the middle of the day. Debris also continually falls including catkins, dead branches and excessive amounts of leaves covering the garden entirely causing concern for children's safety and ability to play within their own garden.
