T1 - Silver Birch

Reduce and reshape by removal of up to 1.5 metres in crown height and 1 metre in crown width. Remove 1 x secondary lateral branch (approximately 50mm dia) overhanging conservatory, back to main lateral. Remove deadwood.

The subject tree requires pruning as specified in order to maintain at a size appropriate to its location and as part of an ongoing management regime. The specified works will not reduce the trees amenity value.
