I wish to remove a Goat Willow, which is now thoroughly rotten and dying, from our back garden. I have attached both a plan of the house and garden showing the position of the tree as a blue cross next to the border of of our garden and our neighbours at Connamara and also a photograph of the tree showing the degree of rot in the main trunk. A number of the branches are also dying such that it now presents a safety hazard to both ourselves

and also our neighbours and the grandchildren they often care for.

You are of course welcome to view the tree should you wish to, to confirm it's condition.

To clarify, the red dashed line on the plan indicates the boundary of the conservation area with the tree lying just within it.
