The proposals seek to re-establish an entrance centrally within the ground floor to improve circulation, demolish the existing lean-to structure within the Kitchen Garden whilst restoring the bread oven and retaining the current flag stone floor, replace the structure with a new curved glass extension to enhance legibility of the bread oven and the rationalisation of circulation within the service wing, reducing the presence of services and new panel door through to lobby area, repurposing the northwest Service courtyard buildings to accommodate a studio and sitting room with fenestration changes, the introduction of wood burning stove/associated flues and replacement curved wall, remodelling of existing staff apartment at the upper floor so this can be used by guests with the removal of modern partisans, gable, chimney and introduction of new windows, repurpose the Common Room to be more informal and useable room with modernised function through the insertion of kitchen island and alterations through the base of sash window to create a low level stable door, remodelling of first-floor master suite by re-establishing the historic Ante Room with adjacent new bath and shower room.

Lean-too structure within Kitchen Garden, forming part of the service wing.

Why is it necessary to demolish or extend (as applicable) all or part of the building(s) and or structure(s)?

We are seeking to restore the existing bread oven and bring this back into use. The existing lean-too structure is unitarian in appearance, and of no architectural merit. This service area has undergone lots of change and the existing enclosure is small in size and an awkward shape in which to prepare bread or bring it back into a useable space. Whilst hybrid options of retaining the structure have been considered during the course of pre-application discussions, the demolition of this structure enables a more coherent extension on the rear of the service wing and improves the legibility of the bread oven itself. It enables an upper floor window to be inserted and the rear wall is back lit by new glazing.
