The application site is located to the western side of the B3079, and comprises a detached two storey Listed Building within the Conservation Area. This application seeks Listed Building Consent for the installation of an air source heat pump, sited upon the western elevation of the dwellinghouse. The main considerations relate to the impact upon the fabric and integrity of the Listed Building. An application for planning permission has also been submitted (22/00006).
