Please describe the proposed works:

Installation of an Air Source Heat Pump to the West end of the property, next to the existing Torpedo Gas bottles currently used to heat the house. The proposal is to site the pump on concrete pad. The electrics and pipework to rise on the exterior to the first floor and enter under the floor boards, minimising the aesthetics and physical impact on the fabric of the house. The floor boards will be listed in the 3rd bedroom and bathroom to bring the pipework to the water tank, hydrobox and buffer vessel, located in the airing cupboard and the Hydrobox sited above the airing cupboard in the loft space. Pipework will then link on the existing pipework back to the where the entry to the heating system will be connected. The old gas boiler will be removed. 2 additional radiators will be fitted, one in the kitchen and another in the conservatory supplied by new pipework fitted to the wall but not affecting the fabric of the property apart from screw holes. One additional radiator will replace existing to provide more heat to the kitchen area. The electrical connections will be made back to the electric supply unit under the stairs.
